Annotation of the educational discipline:

The fundamental change in economic relations in Ukraine made it necessary to review the current legislative framework, update it and adapt it to the new economic conditions. Economic legislation in everyday economic practice. Complex character and numeral normative legal acts in the field of economic activity that change constantly, as well as the possibility of applying customs in the regulation of civil relations, the need because of the ratification of the Association Agreement with the EU of usage of case-law of the European Court of Human Rights in resolving dispute significantly complicate the process of the regulation of economic activity, as well as research and study these processes. Economic law that regulates the production, trade activity of economic entities, i.e., economic relations directly, and undergoes major changes. In connection with this, requirements for future specialists increase - economists on knowledge of the basics of economic law and the skills of applying norms.

In general economic law aims to ensure the growth of economic activity of economic entities, development of entrepreneurship and on this basis to increase the efficiency of social production, its social orientation in accordance with the Constitution of Ukraine, to establish social economic order in the economic system of Ukraine, to promote its harmonizing with other economic systems.

The discipline "Economic Law" is based on the knowledge of students acquired in the study of such academic disciplines as "Law", etc.

The discipline "Economic Law" belongs to the list of disciplines of free choice. It ensures the personal and professional development of the student and aims at forming a complex of knowledge about the rights in the field of economic activity, which is a necessary component of making the right decisions both in the field of management and control of the economy, and in the performance of specific local tasks; in understanding the principles of the protection of rights of the subjects of economic activity.

Purpose of the discipline is the preparation of future specialists in the field of economic and the formation of knowledge of the main provisions of the theory and practice of applying the norms of economic law in the process of economic activity, as well as standards in professional activities for independent problem solving in the organization and implementation of economic activities, and protection of the rights of of the subject of economic activity.

The main **tasks** of the educational discipline is to create a system of knowledge and practical skills and ideas, important for economic activities, assimilation of specific professional terminology, formation of a professionally competent legal language as an important component of the legal culture of the future specialist; that will allow at a higher level study other legal sciences; development of logical thinking, the ability to support own arguments, development of creative aptitudes of students; development of elementary research skills; formation of legal awareness and legal culture, acquaintance with the procedure for resolving economic disputes, formation of skills and abilities of using normative legal acts and drafting of procedural documents in resolving economic disputes.

The subject of the discipline is the totality of social relations in the field of economic activity.

3. Program of the discipline

Economic law as a complex branch of law: the subject and method of economic law. General characteristics of economic relations, their types.

Principles of economic law (use of general legal, branch principles, principles of separate legal institutes).

System of the economic law: a general characteristic. Sources of the economic law: customs and legislation.

General characteristics of economic legislation. Local legislation. The analogy of law and the analogy of the lex. Use of interpretative norms to regulate economic relations.

Topic 2. The concept of entrepreneurship.

General characteristics of economic activity, its types.

Prerequisites for realization of the right to engage in entrepreneurial activity.

Concepts, features and types of entrepreneurship.

Principles of entrepreneurial activity.

Restrictions in the conduct of entrepreneurial activity.

Topic 3. Subjects of economic activity. Organizational and legal forms of economic activity.

Concepts and features of economic activity. Entrepreneurial legal personality (legal capacity and active legal capacity). Types of subjects of economic activity.

The essence of the organizational and legal form of entrepreneurial activity. Entrepreneurial activity of individual entrepreneurs. General characteristics of legal entities, their classification.

General characteristics of certain types of enterprises: state, communal, collective, private, etc.

Legal status of enterprise associations: concept, features and types.

Topic 6. Legalization of subjects of entrepreneurial activity.

Concepts, types and stages of legalization. General characteristics of state registration.

General characteristics of the state registration procedure.

General characteristics of the procedure of making changes and amendments to constituent documents of the legal entity, information about a natural person – entrepreneur.

General characteristics of licensing of economic activity.

Topic 7. General characteristics of the termination of economic activity. Reorganization and liquidation of subjects of economic activity.

Grounds, techniques and forms of termination of subjects of entrepreneurship. General characteristics of reorganization of subjects of entrepreneurial activity.

Liquidation of a subject of economic activity – a legal entity.

Bankruptcy of subjects of economic activity: a) the concept and reasons for bankruptcy; b) proceedings in bankruptcy cases; c) sanation of the debtor; d) liquidation procedure; e) the collection of bankruptcy debts and the procedure for satisfying the claims of creditors.

Topic 8. Property right. Legal regime of property of subjects of economic activity.

The concept of property and property rights in Ukraine. Content of property (estate). Grounds for emergence and termination of property rights. Types (forms) of the property.

Legal regime of property of subjects of economic activity. The right of economic management and operational management.

Contracts, liability and protection of rights

Topic 9. Economic and legal obligations and economic contracts.

General provisions on economic obligations: concepts, types and grounds of economic obligations. Economic contracts, their contents and procedure for the conclusion of economic contracts. Change and termination of economic contracts.

Execution of economic contracts and ways of ensuring obligations.

Topic 10. Control and liability in economic activity.

The concept, types and grounds of legal and economic liability. Economic offenses. Types of economic sanctions and their characteristics.

Concepts, types and forms of control over the implementation of economic activities. Concept and principles of state control (supervision) for the implementation of entrepreneurial activity. Procedure for implementation of comprehensive planning measures of state supervision (control).

Legal status of the Antimonopoly Committee in Ukraine.

Topic 11. Protection of the rights of subjects of economic activity.

The status of economic courts in Ukraine, their system and powers.

The essence of pre-trial settlement of economic disputes.

The subordination and jurisdiction of the economic court.

General characteristics of the time limit for claims: concept, types, starts, stops, interruption and restores of the time limit for claims.

Resolution of economic disputes by economic court.

The list of practical and seminar classes, as well as questions and tasks for independent work is given in the table "Rating-plan of the discipline".

Teaching and learning methods

In the educational process traditional methods are used – verbal (story, explanation, lecture, conversation, discussion, in distance learning – essay, seminar) (topics 1-11), visual (display: illustration, demonstration presentation) (topics 1-11), practical (exercises – situational tasks, cases, creative exercises, performance of creative task, research work) (topics 1-11), control (express-surveys, written control works, final control) (topics 1-11) and independent (analysis of legal acts) (topics 1-11).

In addition, dialogical teaching methods are used (methods of activating educational and cognitive actions) (topics 1-11), in particular, they include analysis of a specific situation, "brainstorming" ("attack") (topics 11), educational and thematic discussion (topics 1-11), business game (topics 6, 7, 11), professional consultation (topics 1-11), etc.

The order of evaluation of the results of training

The system of evaluation of the formed competences in students takes into account the types of classes that, according to the program of the discipline, provide lecture and practical classes, as well as performing independent work. KhNEU named by S. Kuznets uses a cumulative (100-point) evaluation system.

The control measures include:

current control during the semester in the course of lectures, practical classes which is estimated by the sum of the points scored (the maximum amount is 60 points; the minimum amount that allows the student to take the exam -35 points);

modular control, conducted in the form of control work as an intermediate mini-exam on the teacher's initiative, taking into account the current control over the corresponding content module, and aims at an integrated evaluation of the student's learning outcomes after studying the material from the logically completed part of the discipline content module;

final / semester control, conducted in the form of a semester exam, according to the schedule of the educational process.

In the practical lesson, assessment is carried out for active work in the classroom (total 5 points), such as survey and the quality of situational tasks – problem situations, topic revision or preparation and speech with a report.

The general criteria for evaluating non-auditing independent work of students are: the depth and strength of knowledge, the level of thinking, the ability to systematize knowledge on specific topics, the ability to make informed conclusions, the possession of categorical apparatus, skills and

techniques of performing practical tasks, the ability to find the necessary information and legislation, its systematization and processing, self-realization on practical lessons.

Extracurricular independent work involves the implementation of an individual creative task, which is evaluated in 10 points (research work by writing a scientific article, some presentation. etc).

The final control of the knowledge and competences of students in the discipline is carried out on the basis of a semester examination, the task of which is to check the student's understanding of the program material in general, the logic and interrelations between the individual sections, the ability to use the accumulated knowledge creatively, the ability to formulate their attitude to a particular educational problem discipline, etc.

The examination task covers the program of discipline and involves determining the level of knowledge and the degree of mastery of competencies by students.

Each exam task consists of 3 practical situations (one stereotyped, one diagnostic and one heuristic task), which provide for the solution of typical professional tasks of the specialist in the workplace and allow to diagnose the level of theoretical training of the student and his level of competence in the discipline.

The result of the semester exam is evaluated in points (the maximum number is 40 points, the minimum number is scored – 25 points) and is placed in the corresponding column of the examination "Register of the Academic Performance".

The student should be **considered attested** if the sum of the points earned on the results of the final / semester test of success is equal to or exceeds 60. The minimum number of points for the current and modular control during the semester is 35 and the minimum number of points scored on the exam is 25.

The final score in the discipline is calculated on the basis of the points obtained during the exam and the points obtained during the current control over the accumulation system. The total score in the points for the semester is: "60 and more points are counted", "59 and less points are not counted" and entered in the "Register of the Academic Performance" of the academic discipline.
